The CDC has released a new analysis of waterborne disease in the United States following a comprehensive 10-year study. The report, *Estimate of Burden and Direct Healthcare Cost of Infectious Waterborne Disease in the United States*, found that about 7.15 million waterborne illnesses occur annually, leading to more than 6000 deaths.
