# Proposal to amend copper and copper alloy standards AS 1156, AS/NZS 1567, AS 1568, AS 1572 and AS 2738.

Standards Australia advised that the kick-off meeting for the MT-002 Committee, with PPI Group representative Michael Moriarty, will most likely be held mid September 2021.
