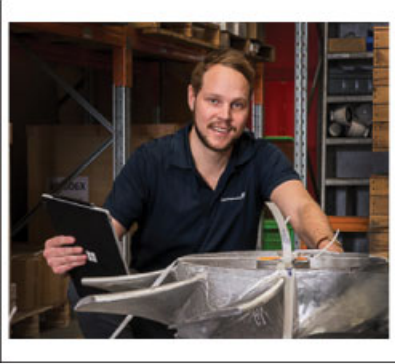

The PPI Group will be holding their first General Meeting of 2022 face to face on 12 April 2022 in Sydney at 2pm. A venue is yet to be organised..

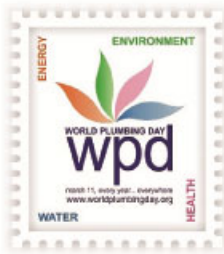

Analysis of quarter one data from the VBA's Proactive Inspection Program's (PIP), collected from July to September, showed that non-compliant building and plumbing issues had increased. This was due to inspections scheduled when works were more advanced on site, which allowed for observation and assessment of more risk factors.
