PPI Group submitted a proposal to remove barriers to improve plumbing product performance

The purpose of this submission is to recommend that governments adopt a national whole of supply chain plan to remove barriers to improve plumbing product performance. The goal is to ensure accountability for all parts of the plumbing product supply chain to mitigate risks to the community of exposure to plumbing products that are either non-compliant or not fit for purpose when being sold, installed or used in the Australian market. NCC 2022 is now available on NCC Online

The ABCB announced that NCC 2022 has been made available on NCC Online. NCC 2022 will be adopted on 1 May 2023, with a transition period to 1 October 2023 for the modern homes provisions for energy efficiency, condensation mitigation and livable (accessible) housing. Until these adoption dates, NCC 2019 Amendment 1 remains in force.

Queensland Development Code for supplementary water supply

Southern Downs Regional Council has been approved to opt-in to the Queensland Development Code (QDC) for supplementary water supply systems. From 1 July 2022, all new residential and commercial buildings within the reticulated water network will be required to have a rainwater tank installed as part of the build.



Building Ministers support new home energy efficiency standards

Building Ministers have agreed to raise the minimum energy efficiency standards for new homes by updating the National Construction Code (NCC). Following the NCC announcement, minimum energy efficiency requirements for new houses and apartments are increasing from the Nationwide House Energy Rating Scheme (NatHERS) equivalent of 6 to 7 stars.
