Dodgy bathroom company crack down!

The Federal Court of Australia imposed significant penalties and legal costs under the WELS Act against a director and his four companies that are registered in Perth. The Director was selling and advertising products that were not registered or had incorrect labelling information, and did so, knowingly, for years. He was provided significant education by the Compliance team prior to warnings and infringement notices, which were not paid, prior to escalation to civil proceedings.
