ABCBC expects new "Lead Free WaterMark" trademark

The Australian building Codes Board (ABCBC) agreed to a 3-year transition period to allow industry to make the necessary changes to provide products to the market in compliance with this requirement. On 21 April 2023, the ABCBC redetermined the commencement and completion dates for the 3-year transition period to support Australia's path to reducing allowable lead levels in many plumbing products. The ABCBC expects a new "Lead Free WaterMark" trademark to be formally registered on 2 May 2023, allowing a Notice of Direction to be issued that same day. The 3-year transition period will commence with the issue of the WaterMark Notice of Direction. All relevant products will be required to meet the new requirements by the specified date of 1 May 2026
