Industry to achieve target of 1.2 million new homes

On 16 August, National Cabinet met in Brisbane and agreed on the target to build 1.2 million new homes over five years from 1 July 2024. States and Territories will receive up to \$3 billion in federal incentives to meet the higher goal, and \$500 million has been allocated for essential services in new housing projects, the latter in a competitive fund to encourage the States and Territories to expedite the delivery of building approvals and housing construction. National Cabinet also agreed to a National Planning Reform Blueprint with planning, zoning, land release and other measures to improve housing supply and affordability.

Standards Australia hosted the ISO Annual Meeting in Brisbane on 18-22 September – the first time it's been held in Australia for 20 years. Building product information requirements

On 11 December 2023, new regulations for building product information requirements will commence. Manufacturers and importers have new responsibilities under the building product information requirements. The new regulations have been made to provide building product users with information about how building products contribute to compliance with the Building Code. They place obligations on Aotearoa New Zealand-based manufacturers, importers, wholesalers, retailers, and distributors.
