The volume market is going to continue to become increasingly the domain of low-cost importers. While this remains a significant part of PPI Group's representation, the message seems to be that many established companies are finding themselves diversifying into many more complex and lower volume products to meet regulations especially in the area of water and energy efficiency.

### *Lobbying*


